## RASCI Affiliated Training Partners,

In continuation to our earlier communications (verbal / written), we wish to reinforce key parameters which would be considered for allotment of target numbers under PMKVY Scheme for the benefit of all the stakeholders whilst keeping the certified learner at the center of all that we do. Alignment with these parameters would enable common objectives.

## Parameters considered for allotment of Target Numbers under PMKVY Scheme:

## 1) Affiliated Training Partners – New:

- a. Number of successfully audited training centres.
- b. Number of RASCI Certified Trainers.
- c. Funded / Specialisation for Retail Skilling.
- d. The number of employer letters desiring to recruit with clearly articulated
  - i. Number of vacancies,
  - ii. Job Roles of existing vacancies,
  - iii. Location of vacancies,
  - iv. Timelines for hiring (within 3 months or beyond)
- e. Constituency based capacity to mobilise and train.
- f. Ability to mobilise candidates in North East, LWE & Jammu and Kashmir regions.

## 2) Affiliated Training Partners - Existing:

- a. Number of successfully audited training centres.
- b. Number of RASCI Certified Trainers.
- c. Funded / Specialisation for Retail Skilling.
- d. The number of certifications done through RASCI.
- e. The % placements of RASCI Certified candidates.
- f. The number of employer letters desiring to recruit with clearly articulated
  - i. Number of vacancies,
  - ii. Job Roles of existing vacancies,
  - iii. Location of vacancies,



- g. Timelines for hiring (within 3 months or beyond)
- h. Constituency based capacity to mobilise and train.
- i. Ability to mobilise candidates in North East, LWE & Jammu and Kashmir regions.

The PMKVY target number will be distributed to Training partners aligned with the PMKVY guidelines to ensure compliance and operational excellence. Please refer PMKVY Scheme Guidelines.

The target number enrolments would be monitored on SDMS as per guidelines and training partners unable to achieve the allocated target numbers as per mentioned timelines would have their unutilized target numbers reallocated to other performing training partners.

As per PMKVY Guidelines the identified job roles for Level 1 to 4 is aligned with NSQF and aims to target school / college dropouts.

Please update details of certified / placed candidates as per template attached along with this circular, as and when the candidates are being certified / placed. To commence this activity, please share placement details for the candidates who have already got certified under PMKVY Scheme.

Please note, placements will be the key parameter for all future target number allocations, hence help us to serve you better by furnishing accurate data in a timely manner, adhering to all PMKVY Scheme Guidelines, engaging with the Industry at the local level to ascertain local manpower requirements, sourcing letters from industry as mentioned, etc.
